### CARLYLE CITY COUNCIL Regular Meeting Monday, January 11, 2010

The meeting of the Carlyle City Council was called to order at 7 p.m. by Mayor Jan Fauke on Monday, January 11, 2010, in the Carlyle Council Chambers.

The following aldermen were present: Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, and David Laws.

City employees present: John Hodapp, Geoff Jones, Kent Newkirk, Chad Holthaus, and Ken Mehochko.

Others present: Joe Burdeau, Don Berdeaux, Jim Bolk, Joe Witthaus, Scott Rakers, Tess Jackson, Darlene Diekemper, Nancy Zieren, Shirley Norrenberns, Toni Litzenburg, Mark Hodapp, Stacie Selle, Kelly Ross, and Frank Richter.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

Minutes from December 28, 2009, were accepted on a motion by Alderman Steve Kauling. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve the treasurer's report as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, and Mike Burton; nay – none.

A motion was made by Alderman Mike Burton to approve claims as presented. The motion was seconded by Alderman David Laws and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, and Ed Kleber; nay – none.

Alderman Burton presented a request from the Street & Alley Department for the purchase of an air compressor. The cost from Gebke is \$769.99.

A motion was made by Alderman Mike Burton to approve the purchase of an air compressor from Gebke at a cost of \$769.99 as requested. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Alderman David Laws reported on the Water/Waste Water Meeting held January 4, 2010. They have been talking with the developer of Vincennes Trail regarding the water line, and the 6" line is not feasible. They will continue discussion about water distribution at that development. The committee also received reports on the new water tower. They are in the second phase of the application process. Alderman Laws noted that interest rates are at 3.25%; and that would be locked in for 40 years.

Alderman Satterfield told the Council that the Police Committee met and discussed the hiring of a part-time officer. That recommendation is on the agenda.

Alderman Perez told the Council that the Street & Alley Committee is looking for a street sweeper that is a little bigger than what they saw. He also reported that the leaf vac is working out pretty good.

Alderman Burton reported that the EDC met and they are going forward with postcard mailers. He also told the Council that his committee reviewed the logo designs that were submitted. They have asked Bill Gruen and Mayor Fauke to look at them before a recommendation is made.

Chief Newkirk told the Council that the crime statistics that he gave them were strictly from their records.

Bill Gruen reported that he has been working on getting ID cards for city employees and elected officials. It will be a picture ID with the city logo. The Police Department already has badges that will serve as their ID's.

Bill Gruen updated the Council on work that HMG is doing regarding the flood plain at Jefferson and 8<sup>th</sup> and 9<sup>th</sup> Streets. FEMA is asking for an additional letter. After they resubmit, a review will take about three months.

Mayor Fauke asked the Council to set meeting dates for 2010.

A motion was made by Alderman Don Perez to set regular meetings of the Carlyle City Council for the 2<sup>nd</sup> and 4<sup>th</sup> Monday of each month. The motion was seconded by Alderman Jack Satterfield and unanimously approved by voice vote.

Chief Newkirk told the Council that their part-time officer pool is short one person since they hired Josh Alberternst as a full-time officer. He recommended hiring Shane Peltes as a part-time officer. Alderman Kleber asked if he lives in the city. Kent said he lives on fairground road.

A motion was made by Alderman Jack Satterfield to hire Shane Peltes as a part-time police officer as requested. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Bill Gruen presented information on the dispute over engineering fees for Gateway Avenue. He noted that the developer is responsible for those fees, and the estimate from HMG was \$50,000. It ended up costing \$77,500, and Wal-Mart is refusing to pay anything over \$50,000. At this time, the city is holding the final plat until this issue is settles. This will keep them from selling any of the three out lots. The Finance Committee met, and they are supportive of paying the additional \$27,500 from TIF 1 funds. Scott Rakers from HMG told the Council that the estimate was based on Wal-Mart's schedule, and it took 2 months longer to complete.

A motion was made by Alderman Mike Burton to approve using TIF 1 funds to pay the amount over \$50,000 for HMG's engineering fees for Gateway Avenue. The motion was seconded by Alderman Steve Kauling and approved by the following roll call vote: Aye – Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Don Perez, and Jack Satterfield; nay – Ed Kleber and Brent Sheathelm.

Bill Gruen presented information on Vincennse Trail subdivision. Frank Richter has 5 lots that front Old State Road, and he would like to start selling them before infrastructure is in place. The estimated cost for a 6" water main is \$17,370, and electric is estimated at \$8828. There would be a 25% maintenance fee of \$6,550. The total guarantee the developer would need from Germantown Bank is \$32,748. Subdivision code allows the city to record final plat before infrastructure is in place.

A motion was made by Alderman David Laws to approve a guarantee of \$32,748 from Germantown Bank for the development of Vincennse Trail as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none.

Toni Litzenburg thanked the city for their support of Christmas in Carlyle.

With no further business, a motion to adjourn was made by Alderman David Laws and seconded by Alderman Don Perez. The motion was unanimously approved by voice vote, and the meeting adjourned at 7:25 p.m.

### CARLYLE CITY COUNCIL Regular Meeting Monday, January 25, 2010

The meeting of the Carlyle City Council was called to order at 7 p.m. by Mayor Jan Fauke on Monday, January 25, 2010, in the Carlyle Council Chambers.

The following aldermen were present: Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, and David Laws.

City employees present: John Hodapp, Bill Gruen, Steve Lappe, Kent Newkirk, Geoff Jones, and Dave Redeker.

Others present: Joe Witthaus, Eric Nave, Matt Rainey, Joe Burdeau, Dennis Rudolphi, Mark Hodapp, Don Berdeaux, Sharon Berdeaux, Duane Nordike, Kelly Ross, and Pat Norrenberns.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

Minutes from January 11, 2010, were presented for approval. Alderman David Laws noted that page 1, paragraph 11 reads that the 6" line is not feasible. It should say that the 4" line is not feasible and they are using 6" line.

A motion was made by Alderman David Laws to approve minutes as amended. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve transfers of \$25,000 to Street & Alley, \$40,000 to Police, \$10,000 to Park, and \$15,000 to Playground for a total of \$90,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, and Ed Kleber; nay – none.

Alderman Burton told the Council that the Finance Committee will meet tomorrow and discuss the annexation. They hope to have a recommendation at the next regular meeting.

Bill Gruen reminded everyone that the boat show is February 10-14. Shirley will be calling for volunteers. He also reported that Cheryl with Serpentine is working on the new website.

Bill Gruen reminded everyone that the bass finals will be held May 7 & 8. He will be meeting with the Tourism Bureau to discuss marketing of the event.

Bill told the Council that 25-30 letters were sent out to regional communities to see about connecting bike trails. He is also working on a residential mailer project to target people who may be interested in re-locating to Carlyle. The project plan will be presented for approval at a later date.

Mayor Fauke presented information on bids received for the pool house project. The low bid for the pool house construction was \$325,805 from Clinton Built and the low bid for pool renovation was \$118,568 from Pisces. Alderman Kleber asked about the metal roof. Mayor Fauke told him that she addressed that at the Park Board meeting and no one disagreed. There was discussion about it being part of the bid. Mayor Fauke said she thought the tin roof was an alternate. There was discussion.

Alderman Laws noted that they are \$75,000 over and asked where they could make cuts to bring the cost down. Mr. Norrenberns stated that the fiberglass door could be changed, but that would only save them \$4,000. He pointed out that the plumbing alone was \$80,000. He added that bids were competitive. Alderman Kauling stated that everything is handicapped accessible and that a lot of requirements drove up the cost.

Alderman Kleber stated that a \$250,000 project could end up costing \$500,000. Mayor Fauke told him that HMG originally told them that the bathhouse alone would cost \$450,000 to \$500,000 plus their engineering fee of \$28,000. She contacted another engineer who saved the city almost \$22,000 just on engineering fees. The pool house then came in lower than we were first told. The wading pool, fence, deck and sidewalk were not in the original plan. After it was sent to the state, the public health department got involved and we were mandated to spend \$50,000 to \$60,000 more just for the baby pool. There was brief discussion. Mayor Fauke went on to explain that they decided to replace the entire fence rather than piece in the sections that were green.

A motion was made by Alderman Don Perez to accept the bid of \$325,805 from Clinton Built for the new bathhouse as presented. The motion was seconded by Alderman Steve Kauling and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, and Don Perez, nay – none.

A motion was made by Alderman Jack Satterfield to accept the bid of \$118,568 from Pisces Pool for Pool Renovations as presented. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Mayor Fauke presented the Old State Commons Subdivision Plat Agreement for approval. She noted that streets will be asphalt or concrete and lots can not be sold until infrastructure is in place. The property is divided by Old State Road, and he can sell the entire property to the north or to the south of Old State Road. Alderman Laws said he would like time to look at the agreement before he votes, and he would like to wait until next meeting to take a vote. It was noted that Ken Mehochko reviewed the draft.

Bill Gruen told the Council that this agreement would allow them to record the final plat. The lien would be the value of the infrastructure plus 50%. As it is developed, the liens will be released. If the north or south bands are sold as a whole, they will have to comply with the agreement.

A motion was made by Alderman Jeff Taylor to approve the Old State Commons Plat Agreement with specific street materials as presented and allow the sale of the north and south bands as explained. The motion was seconded by Alderman Brent Sheathelm and approved by the following roll call vote: Aye – Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – Ed Kleber.

Bill Gruen presented information on the Ameren Labor Market Survey. The set-up cost of \$1,000 would be shared by Carlyle, Centralia, and Mt. Vernon. There would be an additional charge of \$6 per business or employer that we identify to be surveyed. Bill wanted to know if the Council is interested. Don Berdeaux asked what Ameren's interest is. Bill said they have an active economic development office. There was discussion. Bill said he plans an estimated 100 surveys. He added that they highlights of the survey would be used on our website. The Council had no objections with him continuing

Don Berdeaux asked if the city is still looking at an Economic Development person. Mayor Fauke told him that they had done interviews and had a person they wanted to hire, but they could not agree on a salary. They would still like to hire a full-time person, but money is tight. She then told him that there are plans to re-visit this effort in the future. Mr. Berdeaux said he feels it is vital for the city. Mayor Fauke agreed.

Sharon Berdeaux asked about the logo contest. Mayor Fauke said 40-50 logos were submitted. They now have it narrowed down to 3 or 4.

Don Berdeaux asked if the city is planning any other major city projects. Mayor Fauke said she would like to start working on a downtown enhancement project. There is also the water tower and new line project, the 69 Line Project, and new pool house. She added that they are still looking for park ground.

Alderman Taylor asked about the entrance at Dollar General. Mayor Fauke told him that it is not a city street, and there really isn't anything they can do.

With no further business, a motion to adjourn was made by Alderman David Laws and seconded by Alderman Don Perez. The motion was unanimously approved by voice vote, and the meeting adjourned at 7:48 p.m.

The meeting of the Carlyle City Council was called to order at 7 p.m. by Mayor Jan Fauke on Monday, February 8, 2010, in the Carlyle Council Chambers.

The meeting opened with the Pledge of Allegiance led by Alderman Ed Kleber.

Minutes from January 25, 2010, were presented for approval. Alderman Perez noted that the person attending the meeting listed as Pat Norrenberns was Pat Nettemeyer. Any reference to that individual should be changed from Norrenberns to Nettemeyer.

A motion was made by Alderman Steve Kauling to approve minutes from January 25, 2010 as corrected. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve claims as presented. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

A motion was made by Alderman Mike Burton to approve the Treasurer's Report as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Alderman Mike Burton presented a request from the Water Department for the purchase of 7 test and calibrate water meters at \$250 each for a total of \$1,750, 3 saddles and stops at \$678.38 plus a mileage charge of \$90 for a total of \$2,518.38. These items would be purchased from Midwest Meter.

A motion was made by Alderman Mike Burton to approve the purchase of items from Midwest Meter plus a delivery charge as presented for a total of \$2,518.38. The motion was seconded by Alderman David Laws and unanimously approved by the following roll call vote: Aye – Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none.

Alderman Mike Burton told the Council that the Finance Committee met with future Carlyle residents who live in the area to be annexed.

Bill Gruen reminded everyone that the boat show is Wednesday through Sunday.

Bill Gruen told the Council that he hopes to have some purchase requests for the IHSA Bass Tournament at the next meeting. He added that the finals from last year aired on Saturday.

Alderman Burton said they could still use volunteers for the boat show.

Devon DeJournett presented closeout information for the MFT.

A motion was made by Alderman Don Perez to approve form BLR 14231 and the 2009 MFT Closeout as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none.

Alderman Fauke told the Council that Barb Emling is resigning from the Library Board, and she recommended Wendy Folen as her replacement.

A motion was made by Alderman Ed Kleber to appoint Wendy Folen to the Library Board. The motion was seconded by Alderman Jack Satterfield and unanimously approved by voice vote.

Bill Gruen presented information on demolition assistance for a garage at 1190 Methodist Street as requested by Brian Monken. After reviewing this request, the committee decided that they would like to see a change in how this process is done. They would like to have the city seek bids from Bromley, Diekemper, Jondro, and Schaefer to ensure the contractor is insured to do that type of work. Ken said it could be viewed that the city is entering into a contract with the bidder if they seek bids. He suggested they make it clear to the contractor that the city has no liability for whoever is selected. Mayor Fauke asked if this would be an ordinance change or an application change. Ken suggested it be an ordinance change. There was brief discussion.

A motion was made by Alderman Jeff Taylor to approve paying \$700 for the demolition of a garage at 1190 Methodist Street as requested. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and Steve Kauling; nay – none.

Alderman Burton told the Council that the Finance Committee discussed the Taylor, Hitpas, and Kauling Annexation, and they recommend the city waive all tap-on fees. They must hook up to city utilities as soon as they are available. He noted that sewer is not available to the Taylors, but the others are required to hook on. Sewer laterals are at their expense. Although cable is not available at this time, corporate will meet in the spring to make future decisions. Mr. Taylor asked about street lights. Mayor Fauke said she would like to see them out there, but it must go through the Electric Committee. There was brief discussion.

A motion was made by Alderman Mike Burton to waive tap-on fees for the annexation of the Taylor, Hitpas, and Kauling property and require them to obtain city utilities as they become available. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, and David Laws; nay – none.

A motion was made by Alderman Don Perez to approve the Taylor, Hitpas, and Kauling Property Annexation. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, and Mike Burton; nay – none.

Mayor Fauke introduced Jim Bolk who asked to address the Council. She told them that she was advised that all should remain silent and not respond to anything that is said.

Jim Bolk told the Council that he has some concerns about how much the city says he owes. According to Mr. Bolk, the city says it is \$600,000 and he says it is only \$300,000 with \$150,000 owed to Illinois Ventures and \$150,000 owed to the state. He went on to say that the attorney being used by the city is wasting taxpayers' money. He added that the deposition of discovery was not necessary, and it should be done in private. He stated that if it happens again, he will be in contempt of court, because he won't answer unless it is in a private meeting.

Mr. Bolk gave a history of Quip and how they got started. They closed their doors in March 2008 and he said the ink was barely dry before the city came after them for their money. They owed the bank over \$2 million. The equipment was valued at \$1 million and sold at \$25,000. He feels the city should have purchased that equipment and sold it off for \$1 million. He went on to say that the bank foreclosed and got a judgment against him and Tim, but they are allowing them to stay in their homes. He then noted that they owe the IRS \$110,000. Mr. Bolk said he doesn't understand why they are pursuing him, because there isn't anything there. He added that paying this attorney is a waste of tax money, and as a tax payer, he's paying both ways. His suggestion was that level heads sit down and work things out.

Mr. Bolk then said that the person who bought the equipment is operating out of the Tucker plant (the former Quip building), with a payroll of about \$300,000 a year. He added that Tim and Jim Bolk brought that company to this community. Mr. Bolk asked the city to stop their suit, because there's nothing there. He closed by saying that Quip put \$60 million into the community; and when he sent a letter to the aldermen, he did not get one response.

Mayor Fauke told the Council that she and Bill have been working on a business recruitment and retention program. They want to meet the needs of present businesses and entice new ones to come in. Ten letters have already been sent out, and they will meet with one of the business people next week.

Sharon Berdeaux told the Council that the library is participating in "A SnapShot – One Day in the Life of an Illinois Library" on Wednesday, February 10, 2010.

Alderman Kleber stated that the Council was advised not to respond to the letter from Mr. Bolk because of pending litigation. He added that he also received a letter criticizing the city regarding ambulance service. Alderman Kleber wanted to make it clear that the city has nothing to do with EMT's in Carlyle—they are managed by the County Board.

Mr. Bolk told the Council that his letter said nothing derogatory about Carlyle. He went on to say that if you want to build the city, you have to do more than talk up here.

There was additional discussion about the letter regarding ambulance service.

With no further business, a motion to adjourn was made by Alderman Mike Burton and seconded by Alderman Don Perez. The motion was unanimously approved by voice vote, and the meeting adjourned at 7:45 p.m.

A motion was made by Alderman Mike Burton to approve transfers of \$20,000 to Street & Alley, \$60,000 to Police, \$10,000 to Parks, and \$10,000 to Playground for a total of \$100,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Alderman Burton presented a purchase request from Bill Gruen. He is asking for authorization to spend \$6,843 on the following for the IHSA Bass Tournament:

Alderman Kauling asked about the expenditure for volunteers. Bill said he would like to ask organizations to work at the tournament and he would pay them \$300 each day. Alderman Taylor asked if this is the total needed for the event. Bill said he would still need money for other things with the biggest costs being the banquet and local advertising. There was brief discussion. It was noted that the tournament will be held Friday, May 7, and Saturday, May 8.

Alderman Sheathelm reported that the new poles for the upgrade are here. Three of them were put up today.

Alderman Perez told the Council that the Street & Alley Committee met on February 10. The discussed the new requirement for street signs to be reflective by 2015.

Jim Roeckeman reported that the library will have Story Hour on March 6, 2010, from 10 to 11 a.m. They also did a state survey to see how many people are using the library.

Dave Redeker reported that baseball sign-ups will be held March 6, 13, and 20 at the park shed from 8 a.m. to 2 p.m.

Bill Gruen told the Council that there is a piece of software that is used for the message board that is not working. He also reported that the boat show was a success and he thanked all volunteers.

Bill told the Council that he met with Darlene Rodden regarding the 2010 farmers market. She plans to run the market from June 17, 2010, through October 7, 2010. Darlene expects more participants this year.

Devon DeJournett with HMG presented the proposed 2010 MFT Budget. Alderman Taylor asked if any money is set aside for curb and guttering. Mayor Fauke said she hopes to put that in next year's budget. They are also looking at dividing the city into 4 sections for oiling and chipping. They are currently doing 1/3 per year. Don Berdeaux asked about sidewalk repair. He was told that \$8,000 is budget for that work.

A motion was made by Alderman Don Perez to approve the 2010 MFT Budget as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Steve Kauling, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none.

Alderman Steve Kauling presented a recommendation for summer hires. They will receive \$8 per hour until July 1, 2010, when the minimum wage goes to \$8.25. Head guards will receive \$8.40 per hour with an increase to \$8.70 per hour as of July 1. Umpire pay will remain the same. Alderman Taylor voiced concern about scheduling more workers than needed. There was discussion about the application process for next year. Alderman Kauling noted that they received 87 applications by the deadline and 5 late ones. Of the 59 they want to hire, 48 previously worked for the city.

Alderman Burton expressed concern about the city having to pay IMRF benefits on some of these employees. He asked that approval to hire maintenance workers be tabled until the next meeting. Alderman Laws said he sees some of these people working year-round. Mayor Fauke told him that they have more programs as well as Christmas In Carlyle. There was discussion about hiring out the mowing. Alderman Burton reminded the Council that salary cost to the city for an employee being paid \$8 per hour will probably work out closer to \$11 per hour. Dave Redeker added that they spend \$8,000 to \$9,000 every two years for new mowers. There was additional discussion.

A motion was made by Alderman Steve Kauling to approve park department hires for 2010-11 as presented excluding maintenance workers. The motion was seconded by Alderman Mike Burton and approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none. Aldermen David Laws and Steve Kauling abstained.

Alderman Laws asked about a change order for the pool house to add a barrel ceiling. Mayor Fauke told him that it will still be a gable end, but they discussed an eyebrow vs a V style. There are not cost figures at this time. They will be doing smooth brick on the inside and brick pillars instead of vinyl.

Bill Gruen presented information on the letter of credit to allow Frank Richter to record his final plat. Our template for this was not accepted by Germantown Bank. They provided a draft that Bill did not think was sufficient. He felt it was just a maintenance guarantee. The letter needs to address both maintenance and installation. Frank told the Council that the bank does not want to be the middle person withholding money – they just want to be the lender. They would like to see the city revise their letter/ordinance to make it more current. Alderman Kleber suggested we change the wording. There was discussion.

A motion was made by Alderman Jack Satterfield to approve the letter of credit from Germantown Bank for Frank Richter with amendments by Bill Gruen as presented. The motion was seconded by Alderman Ed Kleber and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, and David Laws; nay – none.

Jim Bolk asked the Council to consider curb and guttering on Ridge Street. He also noted that when in Kentucky, a brochure at a rest area listed Carlyle Lake in Vandalia. Bill said he will check that out.

Don Berdeaux told the Council that a real estate representative for the old Wal-Mart building is in town if anyone is interested in that building. Mayor Fauke noted that she and Bill already met with him. She added that Bill also has three leads for the building where KFC/Taco Bell recently closed.

With no further business, a motion to adjourn was made by Alderman Don Perez and seconded by Alderman Brent Sheathelm. The motion was unanimously approved by voice vote, and the meeting adjourned at 7:48 p.m.

Alderman Burton presented a request from Bill Gruen to have a banquet served at Lighthouse Grill for the bass tournament. The cost with dessert is \$9.50 per person for a total of \$2,850 or \$8.50 per person without dessert for a total of \$2,550.

A motion was made by Alderman David Laws to approve \$2,850 for the Thursday night banquet for the bass tournament. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, and David Laws; nay – none.

Alderman Burton told the Council that he will table a request from the library for the purchase of a work station. They will try to get another bid and present a request at the next meeting. He also reminded the Council that they need to review executive session minutes at the next meeting.

Alderman Laws reported that they will have another camera demonstration on Tuesday morning at 7:30 a.m. He also shared a letter from the Board of Health commending the city for perfect compliance in 2009 with their water.

Steve Lappe reported that they will test and recalibrate on Wednesday.

Geoff Jones reminded everyone that Spring Clean-Up is April 21-24.

Dave Redeker reported that there are still two Saturdays left for summer league sign up.

Bill Gruen reported that there will be a Zoning Board meeting on March 25, 2010. They will be discussion a set-back problem, a zoning change from industrial to residential, and a narrow lot set-back. Bill also reported that he, Mayor Fauke, and Alderman Perez are going to Springfield to talk to legislators. If anyone else is interested in joining them, they can let Bill know.

Bill Gruen reported on the conference he attended last week about rural affairs.

Mayor Fauke presented a check for \$500 to Ashley Huels who was the winner of the city logo contest.

Mayor Fauke presented the contract with Clinton Built for the construction of the new pool house. It was noted that page 4, article 9 refers to the architect for the job, but there is no architect. This will be the engineer rather than architect. Alderman Kleber asked why they have to sign an agreement. Mayor Fauke said she asked Attorney Mehochko the same thing, and she was told that it needs to be done that way. Pat Nettemeyer reminded the Council that Gary Grapperhaus will also need a contract. There was discussion.

A motion was made by Alderman Jack Satterfield to approve the contract with Clinton Built for the new pool house as presented. The motion was seconded by Alderman Steve Kauling and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, and Mike Burton; nay – Ed Kleber.

Mayor Fauke told the Council that Mike Langham has resigned from the Library Board, and she recommended Gail Sherman as his replacement.

A motion was made by Alderman Don Perez to approve the appointment of Gail Sherman to the Library Board. The motion was seconded by Alderman Jack Satterfield and unanimously approved by voice vote.

Mayor Fauke told the Council that the Park Board met last week regarding summer hires. She stated that she supports employment of the youth in the community, and she is not in favor of contracting out the mowing. Mayor Fauke added that the board is recommending they raise the IMRF hours from 600 to 1,000.

The recommendation from the Park Board is to hire the list of maintenance workers that was presented at the last regular meeting and raise the IMRF hours to 1,000. Any new hires or non-participating employees will be kept under 1,000 per year. Also, any new City Council members will not be eligible for IMRF. Alderman Kleber noted that this does not exclude the mayor. Alderman Burton recommended they work less hours. Alderman Laws suggested hiring more workers if need be. There was lengthy discussion. Mayor Fauke noted that there are a lot more programs and a lot more mowing to be done. Alderman Burton said they could save \$10,000 this year if they limit hours. Mayor Fauke said it wouldn't be that much. Alderman Burton said it would actually be \$9,700. He added that the IMRF obligation will go from 11% to 15%. There was additional discussion about limiting hours and/or hiring more kids. Mayor Fauke noted that these are year-round jobs because of everything that goes on now. Alderman Laws asked if more maintenance applications were received. Dave Redeker said there were more. Alderman Kauling stated that maintenance workers are usually promoted from the umpire list. There was additional discussion. Alderman Burton said the only labor intensive thing that he sees added lately is Christmas in Carlyle. Bill said they did help with the bass tournament last year.

Alderman Steve Kauling made a motion to hire maintenance workers as presented at the last meeting and raise required IMRF hours to 1,000 for participation. After brief discussion, Alderman Kauling withdrew the motion.

A motion was made by Alderman Steve Kauling to adopt a resolution stating that all new part-time hires must work 1,000 or more to participate in IMRF. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, Mike Burton, and Ed Kleber; nay – David Laws.

A motion was made by Alderman Steve Kauling to hire the list of maintenance workers as presented at the last meeting. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Bent Sheathelm, Jack Satterfield, Jeff Taylor, Steve Kauling, David Laws, Ed Kleber, and Don Perez; nay – Mike Burton.

Mayor Fauke told the Council that there are some issues with the pool house that need to be reviewed. If we paint more than one color, there is a \$560 set-up fee for every time they change colors. There is also a change to vinyl columns and posts, and from 4" to 6" block. The total change order is in the amount of \$1,796. Alderman Burton asked when they decided to use another color. Mayor Fauke told him that the decision to use more than one color was made after bids were received. There was brief discussion.

A motion was made by Alderman Brent Sheathelm to approve the \$1,796 change order with Clinton Built as presented. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Steve Kauling, Mike Burton, Don Perez, and Brent Sheathelm; nay – David Laws and Ed Kleber.

Bill Gruen asked the Council to consider approval of the Wal-Mart infrastructure. (street, water, and sewer) He stated that everything is OK, but it needs formal action by the Council. Eric Nave asked about a time line on the pool house. He was told that they are hoping to be finished the end of May, but it depends on approval from the state.

Mayor Fauke told the council that Bill Gruen has put together a program that offers resources for people wanting to start a business or looking for a job. It offers resume help and job searches. Jim Roeckeman has set up an area at the library where all of these materials can be found.

With no further business, a motion to adjourn was made by Alderman Mike Burton and seconded by Alderman Don Perez. The motion was unanimously approved by voice vote, and the meeting adjourned at 8:08 p.m.

Steve Lappe reported that they will have a sewer camera demonstration tomorrow morning.

John Hodapp reported that they will have a street sweeper demonstration on Thursday.

Dave Redeker told the Council that they are still taking summer league signups.

Bill Gruen reported that there will be a Zoning Board Meeting at 7 p.m. on Thursday.

Mayor Fauke read a letter recognizing John Hodapp as winner of the APPA Larry Hobert Seven Hats Award. This award is given to public power leaders in smaller communities who possess skills in planning and design, administration, public relations, field supervision, accounting, human resources, and community leadership.

Mayor Fauke asked the Council to consider accepting the Wal-Mart infrastructure. She noted that the city will have 1 year from time of acceptance to make sure everything is working as it should. Alderman Laws asked about the storm sewer issue. John Hodapp told him that they think it was caused by a filtration system that they had in the beginning.

A motion was made by Alderman Jack Satterfield to approve the Wal-Mart infrastructure as presented. The following aldermen were present: Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and David Laws.

City employees present: Steve Lappe, Geoff Jones, Jim Roeckeman, Kent Newkirk, Dave Redeker, and Bill Gruen.

Others present: Devon DeJournett, Joe Burdeau, Eric Nave, Robert Harwell, Dave Rodden, Mark Hodapp, and Kelly Ross.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

A motion was made by Alderman Ed Kleber to approve minutes as presented. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve transfers of \$20,000 to Street & Alley, \$40,000 to Police, \$10,000 to Economic Development, \$15,000 to Retirement, \$15,000 to Park, \$15,000 to Playground, and \$5,000 to Library for a total of \$120,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, David Laws, and Mike Burton; nay – none.

Alderman Burton presented a request from the Water Department for the purchase of 4 Neptune handheld meter reading units at a cost of \$5,489.585 each and 4 charging stations at a cost of \$660.158 each for a total of \$24,598.97 from Schulte Supply, Inc.

A motion was made by Alderman Mike Burton to approve \$24,598.97 for meter reading units and chargers as presented. The motion was seconded by Alderman Brent Sheathelm and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, David Laws, and Mike Burton; nay – Ed Kleber.

Alderman Burton presented a request from the Water Department for the purchase of Seaquest from Viking Chemical Company. Seaquest is a chemical that is supposed to clean the pipes and make them last longer. The cost is \$3.50 per pound, and it is estimated that it will cost the city \$14,000 per year. Alderman Laws said that Dave Rodden from HMG was present to address any questions. Alderman Kleber said he thought it was voted down. He then asked if it had any benefits. Mr. Rodden noted that it is a phosphate and it does not have any particular benefit. He added that it is being used by Troy and Carlinville. Alderman Kleber said he would like to have a medical opinion on this chemical before we start adding it to our water. There was discussion.

A motion was made by Alderman Mike Burton to approve approximately \$14,000 per year for the purchase of Seaquest as presented. The motion was seconded by Alderman David Laws and approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, David Laws, and Mike Burton; nay – Ed Kleber and Don Perez.

Alderman David Laws reported on the Water Committee Meeting. He said they are waiting on another study for the water tower and they will table the purchase of the sewer camera until the next regular meeting.

Alderman Kleber asked about the study they are waiting for. Mayor Fauke explained that the districts do not think they have to pay for the cost, so the residents will have to pick up the cost.

She asked Netemeyer to prepare a study on a pump system. Alderman Burton said he thought a pump system would be more expensive. He then asked if the districts will help with that cost. Mayor Fauke explained that they would because they will help with production costs; but they feel a water tower indicates a storage problem. There was additional discussion.

Eric Nave questioned Netemeyer representing both parties. Mayor Fauke told him that it is difficult in a small town. She added that she wants to make sure we are doing the right thing because it would be a substantial increase to the citizens of Carlyle. Alderman Burton questioned her authority to request this study. Mayor Fauke said she checked with Attorney Mehochko, and she does have that authority. Bill Gruen also explained the substantial increase if the districts do not help with the cost. There was lengthy discussion.

Alderman Taylor told the Council that the City Progress Committee is planning a citywide auction sale on October 10, 2010. Proceeds will help fund Christmastown.

Alderman Sheathelm reported that Henkel and McCoy is finished setting poles.

Alderman Kleber reported that John Cavaletto will be presenting the library with an up-to-date set of law books.

Jim Roeckeman reported on the 6 programs scheduled for this summer.

Dave Redeker told the Council that the city has a block of tickets for the St. Louis Cardinals game on Thursday, July 15, 2010. The cost is \$15 per ticket.

Bill Gruen reported on the triathlon held Sunday, May 23. There were 172 participants.

Bill Gruen told the Council that a bike trail planning grant was received about a year ago, and they are working on the final draft. He also reported that the Corp informed him that all camp grounds are full for Labor Day Weekend.

Bill Gruen asked the Council if they are in favor of continuing to host the IHSA Bass Tournament. He noted that he is getting unofficial word from IHSA about extending Carlyle's role as host of the event. There were no objections.

Chief Newkirk told the Council that the first draft of his budget is finished.

Alderman Perez presented the second reading of the labor union contract. Alderman Kleber questioned the raise and asked if they have considered decreasing the work force.

A motion was made by Alderman Don Perez to approve the union labor contract as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Information on the Pool House & Pool Project Financing was presented by Alderman Mike Burton and Bill Gruen. A rate of 3.85% over 10 years was received from 1<sup>st</sup> National Bank. Bill noted that they did check with all local banks, and 1<sup>st</sup> National had the best deal. Alderman Kleber asked for a summary of expenses for the cost of pool renovations. He was told that the information was already presented to the Council. A review of all expenses was discussed. Mayor Fauke added that they should have their permit on Tuesday.

A motion was made by Alderman Mike Burton to approve the Pool House & Pool Project Financing as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Jeff Taylor, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none. Mayor Fauke presented pay request #3 from Clinton Built for work done on the pool house. This request consists of an invoice in the amount of \$29,188.04 and one in the amount of \$49,899.04 for a total of \$79,087.08. They were both reviewed by Pat Netemeyer.

A motion was made by Alderman Don Perez to approve pay request #3 from Clinton Built in the amount of \$79,087.08 as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none.

Mayor Fauke asked the Council to approve her appointment of Jeremy Weh as Alderman to replace Steve Kauling.

A motion was made by Alderman Don Perez to approve the appointment of Jeremy Weh to the Council. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and David Laws; nay – none.

Alderman Weh was sworn in by the city clerk.

Devon DeJournett from HMG presented low bids for the 2010 MFT Program. They are as follows:

The motion was seconded by Alderman Don Perez and approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – Brent Sheathelm.

Bill Gruen told the Council that the city will see a substantial increase for renewal of the health care plan they offer employees. The cost for health, dental, and vision is \$48.39 per month per employee for a total of about \$19,000 per year.

A motion was made by Alderman Jack Satterfield to approve the increase for health care coverage as presented. The motion was seconded by Alderman David Laws and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, and Ed Kleber; nay – none.

Bill Gruen presented information on the clean-up of mold at city hall after the inspection by the Illinois Department of Labor. An expert was called in to give the city a plan for clean-up. Bill asked for Council approval to seek bids for this work.

A motion was made by Alderman Jeff Taylor to seek bids for mold clean-up as requested. The Zoning Board recommended approval contingent upon completion of a fence within 90 days at his duplex on 13<sup>th</sup> Street. A motion was made by Alderman Jeff Taylor to approve a \$3,000 donation to the Fireworks Committee from the Hotel/Motel Tax Fund. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none. An equipment lending policy was addresses by Mayor Fauke. She said she talked to Ken Mehochko about her concerns with damage to our equipment. He suggested an agreement in writing to cover damage to the equipment while it is being used by others.

Mayor Fauke told the Council that they are planning a 4<sup>th</sup> of July Kickoff with a concert downtown on July 2<sup>nd</sup>. They have contacted a band out of Seattle called "The Dusty 45s". During public comments, Joe Burdeau commented on the disrespectful behavior of aldermen during the meeting.

Robert Harwell asked if the city has done anything about putting bills on their website. Mayor Fauke said she has not yet looked into that possibility. There was lengthy discussion about the need to do this and the work that might be involved. Mayor Fauke said she feels information on zoning codes and ordinances would be more beneficial to the citizens. Alderman Burton noted that a list of bills would not make any sense without the invoices. After additional discussion, Alderman Burton said he would look into it.

Alderman Taylor complimented the Park Department on how nice the Fish Hatchery looks.

Mayor Fauke explained that members of the audience are not to speak when the Council is in session. She added that they can raise their hand and be recognized during Public Comments if they wish to comment.

With no further business, a motion to adjourn was made by Alderman Don Perez and seconded by Alderman Jack Satterfield. The motion was unanimously approved by voice vote, and the meeting adjourned at 8:43 p.m.

Bill Gruen told the Council that a Public Forum will be held on Wednesday, June 23, 2010, at 6:30 p.m. to unveil the off-road bike trail plans.

Kent Newkirk reported that the Police Committee will meet at 10 a.m. on Friday to discuss operations.

Mayor Fauke updated the Council on department budgets for Fiscal Year 2011.

Jamie Kohrman addressed the Council regarding the Fall Festival planned for August 28 & 29. There are many events planned such as a kickball tournament, a cake walk, a cutest baby contest, a petting zoo, and bingo. She already has 20 vendors signed up and is hoping to get 60-70. Mayor Fauke said she and Jamie discussed a \$1,500 donation from the city to get this event off the ground. Alderman Kleber asked what they charge vendors. Jamie told him that they each pay a fee of \$50.

Others present: Don Berdeaux, Sharon Berdeaux, Robert Harwell, Mark Hodapp, Eric Nave, Tom Guebert, Barb Guebert, and Kelly Ross.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

A motion was made by Alderman Ed Kleber to approve minutes from June 14, 2010 as presented. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve transfers of \$15,000 to Street & Alley, \$35,000 to Police, \$10,000 to Retirement, \$10,000 to Playground, and \$10,000 to Library for a total of \$80,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

There was discussion about clean-up of mold in the basement. Chase Environmental was the only bidder at \$13,500. Preliminary work was done by Fungus-A-Mungus, and the city owes them \$1,605 for that study. Alderman Sheathelm asked if they can get the water infiltration taken care of. He was told that humidifiers are in place at this time, but that will not take care of the problem. Bill Gruen added that the city is required to clean up the problem.

A motion was made by Alderman Mike Burton to approve \$1,605 to pay Fungus-A-Mungus for services. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

A motion was made by Alderman Mike Burton to accept the bid of \$13,500 from Chase Environmental Group for mold clean-up. Bill Gruen asked the Council to hold off on that decision at this time. Alderman Burton withdrew his motion.

Alderman Weh told the Council that T.J. Boyd asked the Park Board for permission to use the park for fitness classes. Alderman Kleber added that he will be charged \$5.00. Robert Harwell asked about liability. Mayor Fauke told him that proof of insurance will be provided.

A motion was made by Alderman Jeremy Weh to allow T.J. Boyd to use the park for training exercises. The motion was seconded by Alderman Don Perez and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – Ed Kleber.

Alderman Taylor reported that the City Progress Committee met and they have some concerns about bricks falling from the Art of You building. Bill Gruen added that they have concerns with another building downtown. Alderman Taylor then reported that the fireworks on Saturday night will be done by a new person and will have bonus items.
Alderman Perez reported that the Employee Concerns Committee will meet tomorrow, June 29, to discuss non-union wages.

Alderman Kleber questioned putting Steve Kauling's name on the plaque for the new pool house. Mayor Fauke noted that there was not an official vote on whether his name should or should not be included. Alderman Kleber said he has received numerous complaints. There was brief discussion.

A motion was made by Alderman Don Perez to remove Steve Kauling's name from the pool house plaque. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Alderman Burton stated that he has received complaints about the cost of the plaque. Mayor Fauke said she did not recommend the cheaper one because it would not hold up.

Alderman Mike Burton reported that the Finance Committee went over the proposed budget and gave John Hodapp the thumbs up for not having an electric rate increase since 1991 and not expecting one in the near future.

Jim Roeckeman reported on the Reptile Experience summer program. The next program is Nitro Joe. Jim also thanked John Hodapp for repairing the electric this morning.

John Hodapp told the Council that they will be oiling July 27 and 28. Alleys can be done for \$450 by calling city hall before July 21.

Dave Redeker reported that the next movie in the park is on July 10.

Bill Gruen said he would like to get bids for repair of the stairwell ceiling. He also reported that the new city website is up and running. It was designed by Serpentine Web Solutions.

Bill Gruen reported that there was a public forum on June 23 for the draft version of the bike trail plan at Carlyle Lake. A grant was received from DNR. The draft is available at city hall and also on the website.

Bill Gruen received a letter from FEMA, and the flood plane was approved effective July 22. Some people who were in the flood plane before may not be now and some may have been added. He said anyone needing flood insurance might get a cheaper rate if they purchase it by July 22. Tom Guebert explained that flood insurance is not available right now.

Mayor Fauke commended John Hodapp for receiving the 7 Hat Award.

Mayor Fauke presented the first reading of the FY 11 Appropriation Ordinance. There will be a public hearing on July 12 at 6:45, and the Council will be asked to approve the ordinance at the July 12 meeting.

Bill Gruen presented information on the variance request from Bob and Wendy Folen for a pool and fence at 2823 Senate Court. The required setbacks for the pool are 15 feet on the side and rear. They are asking for a setback of 12 feet on the side and 5 feet to the rear. They also asked for a 6 inch rear setback for a black wrought iron fence. The Zoning Board recommended approval.

A motion was made by Alderman Dave Laws to approve the pool and fence variance at 2823 Senate Court as requested by Bob and Wendy Folen. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sehathelm; nay – none. Bill Gruen told the Council that the City Progress Committee had a request for demolition assistance for a garage at 1290 Clinton Street, but it was denied because the owner did not get the required four bids. She wants the contractor that is building the new garage to do the demolition. She can have him do it, but the city will not reimburse her for half of the cost.

Robert Harwell thanked the city hall staff for information provided to him and also thanked the mayor for meeting with him.

Don Berdeaux asked why minutes from 2010 were not on the website. Bill said he told Cheryl to make that a priority.

Barb Guebert reported that over 120 people attended the last library event. She thanked Dave Redeker for setting up the stage that they borrowed from the high school.

A motion was made by Alderman Don Perez to enter into Executive Session to discuss litigation. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – Ed Kleber.

The Council entered into Executive Session at 7:35 p.m.

The Council returned to Open Session at 7:50 p.m.

The meeting of the Carlyle City Council was called to order at 7 p.m. by Mayor Jan Fauke on Monday, July 12, 2010, in the Carlyle Council Chambers.

The following aldermen were present: Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws.

City employees present: John Hodapp, Kent Newkirk, Dave Redeker, Geoff Jones, Bill Gruen, and Ken Mehochko.

Others present: Rachel Thomas, Robert Harwell, Pat Netemeyer, Dick Connor, Carl Huels, Sharon Berdeaux, Mark Hodapp, Duane Nordike, Melinda King, Kelly Ross, Eric Nave, and Liz Greenwood.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

Minutes from June 28, 2010, were presented for approval. Alderman Laws noted that the minutes indicate that T.J. Boyd will be charged \$5 to use the park for training. T.J. will actually be charging \$5 per participant.

A motion was made by Alderman David Laws to approve minutes as noted. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve the Treasurer's Report as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

A motion was made by Alderman Mike Burton to approve claims as presented. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Don Perez, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – Ed Kleber. Alderman Brent Sheathelm abstained.

Alderman Mike Burton presented a request from Mayor Fauke to purchase 2 park benches and 2 trash receptacles from Ultra Play for the bike path. The total cost with freight is \$2,639.60 and the money would come out of the Street Fair Fund. It was noted that the Corp of Engineers will pour the concrete.

A motion was made by Alderman Mike Burton to approve \$2,639.60 for benches and receptacles as requested. The motion was seconded by Alderman David Laws and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Alderman Burton presented a request from Bill Gruen to purchase an advertising package from "The Bull" radio station. The cost is \$3,060 and it will come out of the Hotel/Motel Tax Fund. Bill explained that the radio station will have a contest with the winner receiving a free stay at Carlyle Lake over Labor Day weekend. There was talk about excluding Carlyle and/or Clinton County residents. Alderman Burton questioned the legality of that. Bill explained that the contest is to create interest from outside the area. Sharon Berdeaux asked who will be judging the entries. She was told that the radio station will select a winner. There was brief discussion.

A motion was made by Alderman Mike Burton to approve \$3,060 for a radio contest as presented. The motion was seconded by Alderman Jeff Taylor and unanimously approved by

the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Alderman Laws reported that the Finance and Sewer Committees met two weeks ago. They agreed to purchase a meter for the 12" main at a cost of \$4,200. Alderman Burton stated that they city is not sure it is a meter problem, but they are trying to satisfy everyone from their end. Alderman Kleber added that he met with Barney Heiligenstein regarding this issue. He referred questions to Geoff Jones and Ken Mehochko. Geoff told the Council that there will be a boil order when it is switched out. He added that the company they are purchasing from will come out and calibrate the meter every year free of charge.

Alderman Weh reported that they received seven bids on the old picnic tables. The highest was \$75.15 and the lowest was \$11.05. He asked the Council to accept the highest bid and allow that person to take choice of tables. They would then go to the next highest bid with choice of what is left and so on down to the lowest bid until all tables are gone.

A motion was made by Alderman Jeremy Weh to accept the bid of \$75.11 per picnic table with choice then going to the next highest bidder until all tables are gone. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none.

Alderman Jack Satterfield reported that the Police Committee met on Tuesday and discussed a new squad car.

Alderman Perez reported that the Employee Concerns Committee met on Tuesday, June 29, and discussed raises for non-contract employees. They are recommending the following raises:

Alderman Perez reported on the Street and Alley Committee Meeting held July 6 at 1 p.m. They discussed using rolled compacted concrete on Sand Ridge Road and 21 Street. The committee would like to try this on 21<sup>st</sup> Street. They will first go to Collinsville and look at streets there that were paved with this material. Alderman Laws asked about cost. John Hodapp told him that it would be less expensive.

Alderman Perez reported that bids for the street sweeper will be opened on July 21 at 10 a.m. Oiling and chipping will be done July 27 and 28. The committee also discussed shirts for Street and Alley workers. He added that rock sales are going good.

Sharon Berdeaux reported that the library events are continuing with the next one to be held on Thursday. The last one is a ventriloquist scheduled for July 30<sup>th</sup>. She also reported that the library has a website available that offers simple legal help. Alderman Perez noted that he has gotten several positive comments about the summer programs.

Dave Redeker reported that the pool is open.

Bill Gruen reported that the Zoning Board will meet on July 22.

Mayor Fauke presented a pay request from Clinton Built in the amount of \$48,087.09. This is the final payment. Alderman Laws questioned doors that are not working. Duane told him that he is taking care of those issues.

A motion was made by Alderman Don Perez to approve payment of \$48,087.09 to Clinton Built as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and Jeremy Weh; nay – none.

Mayor Fauke presented a pay request from Pisces Pools Plus in the amount of \$86,284.37. Dave Redeker noted that they still have a few things to finish up. The city is withholding \$1,000 until that work is completed. Janine asked if the \$1,000 was included in the amount being approved. She was told that the total owed is \$87,284.37 and they are only approving \$86,284.37 at this time.

A motion was made by Alderman Jack Satterfield to approve \$86,284.37 for Pisces Pool as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

Melinda King asked the Council when they plan to fix the drainage problem at 4<sup>th</sup> and Fairfax. Mayor Fauke told her that she has been out there several times to look at the problem, and options have been discussed. It was noted that a grate is needed to keep the water from going across the street. There was lengthy discussion. Mayor Fauke told Ms. King that it could be 3 to 4 months before they can address this problem due to other projects in the works at this time.

Mayor Fauke presented the second reading of the FY11 Budget.

A motion was made by Alderman Don Perez to approve the FY11 Budget as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

Mayor Fauke presented the Prevailing Wage Ordinance for approval.

A motion was made by Alderman Mike Burton to approve the Prevailing Wage Ordinance as presented and waive the second reading. The motion was seconded by Alderman Ed Kleber and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, and Ed Kleber; nay – none.

No action was taken on the Demolition Assistance Program Amendments.

No action was taken on the bid for mold remediation. It was noted that the basement has to be sealed first. Bill Gruen talked to Chase and they told him that their bid is good for 6 months.

Alderman Satterfield asked the Council to approve seeking bids for a new squad car. Chief Newkirk said he assumes the old car will be sold.

A motion was made by Alderman Jack Satterfield to approve seeking bids for a new squad car. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

No action was taken on the Sex Offender Ordinance to increase the restriction buffer for residence and loiter of child sex offenders.

Mayor Fauke presented information on the Solicitors' Registration Fee increase. She said they hope to discourage door-to-door solicitors with a higher fee. The Council will take action on this proposal at the next regular meeting.

Alderman Laws asked Pat Netemeyer about the status of the water tower study. Pat said he's waiting for information from HMG. Alderman Burton questioned \$2,000 being spent without Council approval. Attorney Mehochko said the policy allows up to \$2,000. Mr. Harwell stated that the mayor provided the information he requested regarding that issue, but the information did not answer his question. Mr. Mehochko noted that the Council has the authority to control spending. Where that level is drawn is strictly up to them.

Mayor Fauke asked the Council to wait while she went downstairs to get the information they were questioning. Mayor Fauke returned and told the Council that the file cabinet with all minutes was locked, and she was not able to retrieve the information she needed. She went on to explain that the top of a purchase request is the actual request and the bottom of the form is the policy. Prior to the action taken in 1997, the bills that were being approved were for money that was already spent. Alderman Burton said he still can't understand how someone can go out and spend that kind of money without running it by someone else. Mayor Fauke informed him that she did not do that alone. Bill Gruen was in the office with her and they had Ken Mehochko on the speaker phone.

Alderman Burton stated that the Council has already approved the water tower. Mayor Fauke asked how many hundreds of thousands of dollars were put into the hydro plant that never came about. She added that they were told that interest rates were going to go up and they actually went down. She went on to point out that she makes decisions about spending city money every day.

Ken Mehochko told the Council that the only authorization that exists is the one adopted in 1997. It can be revisited and changed.

There was discussion about getting information from HMG. Pat Netemeyer said he does not have all of the information he needs. Geoff Jones told the Council that he spoke to Brian Buchheit and Dave Rodden, and they said they sent everything to Netemeyer. Alderman Laws said he would get with them tomorrow and see what's going on.

Alderman Kleber questioned a conflict of interest since Netemeyer is the engineer for the water district. Alderman Burton said he heard that our study was presented to the water district by Mr. Netemeyer. Pat said he feels Jim Green is a good operator and he values his opinion. There was brief discussion.

Mayor Fauke said she will furnish minutes to Alderman Burton that show her authorization to spend the money for this study. She went on to say that it was done out of concern for the citizens of Carlyle. Mayor Fauke stated that water sales are down and the water department is in the red. A new tower would mean an increase. Alderman Burton said he thinks Bill Gruen made an assumption regarding the rate hike.

Mayor Fauke told the Council that she is in her office almost every day, and they can stop by and talk to her any time.

Dick Connor addressed the Council regarding the "Cruz-IN the Dam" 17<sup>th</sup> Annual Car Show. They will have over 400 classic cars. He asked if the city could again provide additional electric hook-ups and lighting. Mr. Connor went on to explain that the first cruise will start at 4:30 and end up at the MicroTel. The second cruise will go back across the dam, through downtown, and out to Bretz's. He asked for a donation of \$1,200 from the city to pay for radio advertisement. Mr. Huels noted that 90% of the people that come for this event are from out of town. It is a no-charge event, but they will be selling 50/50 tickets to help pay for the entertainment. The event is scheduled for Friday, August 13. Mayor Fauke asked John Hodapp and Kent Newkirk to provide support again this year. Alderman Laws asked about taking some of the money out of the Hotel/Motel Tax Fund. Bill said that some of it could come out of that fund.

A motion was made by Alderman Brent Sheathelm to approve \$1,200 to help advertise the Cruz-IN the Dam car show as requested. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Liz Greenwood from American Red Cross addressed the Council about the upcoming blood drive to be held at the VFW on Tuesday, July 20, from 2-6 p.m. She encouraged everyone to come out and give blood.

With no further business, a motion to adjourn was made by Alderman Don Perez and seconded by Alderman Jack Satterfield. The motion was unanimously approved by voice vote, and the meeting adjourned at 8:33 p.m.

The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Jeremy Weh, David Laws, Mike Burton, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – Ed Kleber.

Bill Gruen presented a variance request from Nancy Patterson for the installation of an above ground pool at 1531 Mulliken Street. She is asking for a 6 ft. side set-back and a 10 ft. rear setback. The Zoning Board asked about the location of the fence. They were told that the fence will be around the deck of the pool. They recommended approval.

A motion was made by Alderman Jeff Taylor to approve the variance request from Nancy Patterson for an above ground pool at 1531 Mulliken Street as requested. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and Jeremy Weh; nay – none.

Fred Becker presented information about the FY10 Water Department Production Costs Report. Total production costs were \$825,463 compared to \$795,918 the year before. He reviewed the breakdown of costs. It was noted that we are selling less water to districts and there will be an increase. The rate increase goes into effect July 1. Alderman Taylor asked if our rates are competitive. Alderman Burton said we're in the ballpark. There was discussion.

A motion was made by Alderman Mike Burton to approve the Water Production Costs Report as presented. The motion was seconded by Alderman David Laws and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

Bill Gruen presented information on action that needs to be taken to allow the developers of Old State Commons to refinance. The agreement for the development is that a lien will be placed on undeveloped lots. The owners want to refinance with Germantown Trust. In order for them to do that, the city must subordinate their second position to that bank.

A motion was made by Alderman Jeff Taylor to approve the lien subordination for Old State Commons as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

Alderman Perez presented bids for the new street sweeper. Woody's submitted a bid of \$114,615, and E.J. Equipment submitted a bid of \$109,990. John Hodapp told the Council that it would cost over \$19,000 to get the old one up and running. It is a 1995 model. Alderman Burton said he doesn't know how long the city can keep spending money like this. Alderman

Kleber agreed. There was discussion. Alderman Satterfield asked about the overhaul. John said he was told that it would last 3-5 years. Alderman Satterfield then questioned the cost of changing out the air conditioning. In regards to spending, Alderman Burton mentioned the recent raises that will be a fixed cost to the city. He noted that revenue is not going up enough to keep up with the spending. Alderman Perez told him that they were told the new sweeper would last about 15 years. There was question about selling the old one. It was noted that a trade-in amount was included in the bids.

A motion was made by Alderman Don Perez to approve the purchase of a street sweeper from E. J. Equipment for \$109,990. The motion was seconded by Alderman Jeff Taylor and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jeff Taylor, and Jeremy Weh; nay – Jack Satterfield, David Laws, Mike Burton, and Ed Kleber. Mayor Fauke voted yes to break the tie and the motion was approved.

Mayor Fauke recommended re-appointments of Barb Guebert (3-year term), Wendy Folen (3-year term) and Ed Kleber (Chariman) to the Library Board.

A motion was made by Alderman Jack Satterfield to approve the Library Board re-appointments as presented. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

Robert Harwell asked for information on the meeting with HMG to resolve the software issue. Mayor Fauke stated that she was told that the men would take care of it. She went on to say that she told Mr. Netemeyer that he didn't need to go to that meeting, but the meeting was not cancelled. Bill said he may have misunderstood. Alderman Laws said he told Bill Gruen to cancel the meeting if Pat wasn't going to be there. Mayor Fauke said she and Bill met with Brad Hummert and Dave Rodden; and they are still trying to supply Pat with the information. The mayor told them that she wanted information pertinent to the water tower study in her office on Friday. Mr. Harwell said his perception is that some people want to go one direction and the mayor wants to go another direction. There was lengthy discussion.

Alderman Burton said he received a call from someone who said he was trying to increase their rate by \$7. He made it clear that that was not the case, stating that this project started with the citizens in mind. He went on to say that eventually the old water tower will have to be replaced. He added that the \$7 increase was if we lost every district. Alderman Kleber told the Council that fire protection rates will go up without water towers.

Mayor Fauke stated that the Water Department is in the red and sales to districts has seen a 2/3 decrease. She then questioned if we need another tower if we lose the districts. Alderman Burton said the water tower is for pressure. He added that the engineering fees of \$168,000 came out of the Water Department and that's why they're in the red. Mayor Fauke stated that approximately \$300,000 is gone from reserves. She went on to say that she just wants to make sure we need this water tower before we move forward.

Alderman Sheathelm asked about the information Mayor Fauke is going to get on Friday. She told him that HMG said they won't be able to answer all of Netemeyer's questions. Alderman Sheathelm said he would like to set a date for Netemeyer to complete his study or hire someone else. Bill said he asked HMG for confirmation that a third water tower is needed for operations. Mayor Fauke added that Ken Mehochko said this would be important information because we can then prove that it is needed and help with the cost can be passed on to the districts.

Alderman Kleber said he talked to Barney Heiligenstein, and Barney told him that TIF money could be used for infrastructure. Mayor Fauke said they have already looked at that. She went on to say that she is not fighting the water tower. She is merely looking at pumps vs. a tower to make sure they make the right decision. There was brief discussion.

With no further business, a motion to adjourn was made by Alderman David Laws and seconded by Alderman Ed Kleber. The motion was unanimously approved by voice vote, and the meeting adjourned at 8:08 p.m.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

A motion was made by Alderman Ed Kleber to approve minutes from July 26, 2010, as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve the Treasurer's Report as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and Jeremy Weh; nay – none.

Alderman Burton presented claims for approval. Alderman Kleber questioned the purchase of a roof top air conditioner and a T.V. Steve Lappe explained that the purchases were to convert a van that will be used for the sewer camera.

A motion was made by Alderman Mike Burton to approve claims as presented. The motion was seconded by Alderman Don Perez and approved by the following roll call vote: Aye – Mike Burton, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – Ed Kleber. Alderman Kleber clarified that his "no" vote was because of the street sweeper bill.

Alderman Burton presented a request from Dave Redeker for tree trimming. The low bid was from Campbell Tree Service at \$1647.

A motion was made by Alderman Mike Burton to approve \$1647 for tree trimming as presented. The motion was seconded by Alderman Don Perez and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – Ed Kleber.

Alderman Burton presented a request from Dave Redeker for a PA system from I E Communications for the new pool house. The total cost would be \$2,224.62.

A motion was made by Alderman Mike Burton to approve \$2,224.62 for a new PA system at the pool house as requested. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – Ed Kleber.

Alderman Laws reported that they lost the backwash pump on Friday. Steve Lappe added that the first 5 ft. of pipe is bad and the pump is being repaired in St. Louis.

Alderman Weh reported that the Park Board met last Monday and discussed insurance on the pool.

Alderman Taylor reminded everyone about the upcoming citywide garage sale as well as the citywide auction in October.

Alderman Sheathelm reported that his committee discussed street lights from Lake Road to Bretz's Wildlife. The cost would be about \$18,000. It was noted that this north expansion is the only one without lights. Eric Nave asked about LED lights. John Hodapp told him that the ones they use are not available. There was brief discussion.

A motion was made by Alderman Brent Sheathelm to seek bids for materials to install street lights from Lake Road to Bretz's Wildlife and get IDOT authority. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Alderman Perez reported that the street sweeper arrived last Wednesday. They are going to get a screen so they can pick up chat. They also got a couple of add-ons at no cost.

Sharon Berdeaux reported on library activities. Mayor Fauke complimented the Library Board on all the hard work they did for the summer programs.

Alderman Burton told the Council that the EDC met and tentatively approved the tourism budget. They also met with Al Crocker regarding his new radio program.

Steve Lappe reported that the construction permit was received.

Dave Redeker told the Council that this is the final week for soccer sign-ups. He also reminded everyone that the Arts & Crafts Festival is August 28 and 29. There was discussion about the soccer field.

John Hodapp reported that they are working at the annexed property on Old State Road.

Chief Newkirk reminded everyone that school will be starting and they need to pay attention to crosswalks. He also reported that the Police Committee will meet at 10 a.m. on August 20.

Bill Gruen introduced Lisa Spaulding who is working with the Street Fair Committee. He asked the Council to consider approval to pay a deposit of \$8,658.25 for the following expenses:

The amounts for Donnewald, Imming, and Excel Bottling represent 100% of the cost. He added that there is no deposit due for carnival rides, but they require a \$5,000 minimum sale of ride tickets. If they do not sell that many tickets, the Street Fair is required to make up the difference. Bill told the Council that there is currently \$17,879.92 in the Street Fair Fund held by the city.

Lisa also asked for the closing of the following streets for this year's event:

8<sup>th</sup> Street – from Highway 50 to Fairfax Street closed on Thursday at 8 a.m. 9<sup>th</sup> Street – from Highway 50 to Fairfax closed Friday at 8 a.m. Fairfax Street – 8<sup>th</sup> Street through 9<sup>th</sup> Street closed Friday at 8 a.m. Fairfax from 8<sup>th</sup> to 7<sup>th</sup> closed Saturday 8 a.m.

Chief Newkirk also suggested 8<sup>th</sup> Street and 9<sup>th</sup> Street at the alleys between Jefferson and Fairfax. There was discussion about closing 7<sup>th</sup> Street Saturday for the water fight. Lisa asked that those be included in her request.

Mayor Fauke said that U S Bank is concerned about courthouse employees using their lot. Lisa asked that the county lot be available for employee parking. There was also discussion about the Street Fair being the same weekend as the Art and Wine Festival.

Alderman Burton noted that the deposit amount needed is less that the amount currently in that account.

A motion was made by Alderman David Laws to approve street closures for the Street Fair as requested. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Don Perez to approve \$8,658.25 from the Street Fair Fund to pay deposits as requested. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

There was discussion about the new water tower. Mayor Fauke stated that it would be a \$2.91 million project compared to \$750 for pumps. She told the council they need to come up with a debt relief plan. Jim Green with the water districts addressed the Council regarding their plans for a new tower. He said that the new plant helped water considerably to the east, but they still have issues on the west end. He is concerned about water quality with another tower. Alderman Burton said one of the major considerations was that the water tower on the east is about at the end of its life span, and it will eventually come down. The new tower is also for pressure. There was discussion. Steve Lappe told Mr. Green that there is a special phosphate that helps with the chlorine problem. Alderman Taylor asked if we need to keep the other two towers full. Dave Rodden said the west tank has to be maintained at full level. He added that if the west end develops, they will need a third tower. There was additional discussion. Mayor Fauke turned the issue over to Alderman Laws who is the Water Committee Chairman.

Pat Netemeyer said that the Clinton County East contract with Carlyle states that they will not pay for any distribution costs. Alderman Burton said that if it costs the city more, it will cost the districts more. Mr. Netemeyer said only for production costs. There was discussion. Alderman Kleber asked Mr. Netemeyer who he was representing tonight. Mr. Netemeyer said he was there for the district. There was additional discussion about the contract. Mr. Netemeyer asked if the Council feels that the districts will help with the cost. Mayor Fauke said there has been discussion about that. Geoff Jones noted that when the city shuts down at night, the districts have to pull water out of the storage tanks. Mr. Green told him that they have enough storage that they wouldn't have to pull out of the tanks at night. It was stated that the districts are going to fight paying for the cost and they wanted the Council to know that before they take a vote. Alderman Kleber asked why the Council isn't privy to any of this information. He added that he met with Barney at a clubhouse on the river. Mayor Fauke noted that he didn't invite the rest of the Council to attend that meeting.

Bill Gruen presented the FY11 Marketing Plan with the Tourism Bureau. They recommended a commitment of \$28,493. Alderman Burton told the Council that the EDC recommended approval of this tentative budget.

A motion was made by Alderman Mike Burton to approve the \$28,093 Tourism Budget as presented. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none.

Bill Gruen presented a fireworks contract for the Christmas in Carlyle celebration in the amount of \$4,000. He noted that it was similar to years past. There was discussion about the 30% cost in case of cancellation.

A motion was made by Alderman David Laws to approve \$4,000 for Christmas in Carlyle fireworks as presented. The motion was seconded by Alderman Don Perez and approved by the following roll call vote: Aye – Jeremy Weh, David Laws, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – Mike Burton and Ed Kleber.

Bill Gruen told the Council that Rita has been looking into an electronic payment plan for utility bills. E-pay offers a system for payment by debit card or credit card. There are two options for the Council to consider. The first is a charge per transaction and the second would be a fee paid by the customer with a \$.65 minimum charge. Bill recommended the customer pay any cost.

A motion was made by Alderman Brent Sheathelm to approve the E-Pay system with the city paying the fee. The motion died for lack of a second.

Chad Holthaus asked to Council to consider a street closure for the St Mary's Church picnic on Sunday, September 19, 2010. He asked for the closure of Livingston Street between 11<sup>th</sup> Street and 12<sup>th</sup> Street from approximately 11 a.m. until 7 p.m.

A motion was made by Alderman Don Perez to approve the closure of Livingston Street between 11<sup>th</sup> and 12<sup>th</sup> Streets for the St. Mary's Church picnic as requested. The motion was seconded by Alderman Jack Satterfield and unanimously approved by voice vote.

Robert Harwell asked if the city could post a squad car by the high school to keep traffic in check with school starting. Alderman Taylor then asked about a radar sign. Chief Newkirk said he could check into the cost. He added that parents with children at the other schools want the same consideration. Chief Newkirk assured Mr. Harwell that his people are already patrolling the area.

With no further business, a motion to adjourn was made by Alderman Don Perez and seconded by Alderman Brent Sheathelm. The motion was unanimously approved by voice vote, and the meeting adjourned at 8:15 p.m.

The meeting opened with the pledge of allegiance led by Alderman Ed Kleber.

Minutes from August 9, 2010 were presented for approval. Alderman Laws noted that page 3 should read a cost of "\$750,000 for pumps."

A motion was made by Alderman David Laws to approve minutes from August 9, 2010, as amended. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

Alderman Burton presented a request to purchase poles for the street lights that are going up along Route 127 North. The cost from Brownstown Electric is \$14,162.41.

A motion was made by Alderman Mike Burton to approve \$14,162.41 for poles from Brownstown Electric as requested. The motion was seconded by Alderman Ed Kleber and unanimously approved by the following roll call vote: Aye – Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

Alderman Burton presented a request from Bill Gruen to spend \$9,600 for a video production to promote Carlyle with the money coming out of Economic Development (\$1,000), Hotel/Motel Tax Fund (\$2,000), TIF 1 (\$1,800), TIF 2 (\$3,000), and TIF 3 (\$4,500).

A motion was made by Alderman Mike Burton to approve \$9,600 for a promotion video as requested. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

A motion was made by Alderman Mike Burton to approve transfers of \$120,000 to Street & Alley, \$35,000 to Police, and \$20,000 to Playground for a total of \$175,000. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, and Ed Kleber; nay – none.

Alderman Taylor reminded everyone about the citywide garage sale to be held September 16, 17, and 18. He asked Bill about a map of participants. Bill told him that for the Spring event they made up a map and told people different locations where it could be picked up. He plans on doing it that way again, because it is a lot cheaper than printing the map in the local paper.

Alderman Satterfield told the Council that the low bid received for a new squad car was \$31,857, and the committee rejected all bids. They found a 2010 Ford Explorer with full warranty for 22,415, and recommend purchasing that vehicle.

A motion was made by Alderman Jack Satterfield to purchase the 2010 Ford Explorer at \$22,415 for the Police Department. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Alderman Perez told the Council that citywide clean-up is scheduled for September 22-25. They will not be taking tires this year.

Jim Roeckeman reported that the library will be having their book sale September 17 & 18.

Dave Redeker reminded everyone that the Fall Festival is scheduled for this weekend and they will have a movie in the park Saturday night. He also reported that they will keep the pool open until the end of September.

Bill Gruen reported that the Zoning Board will meet on September 9, 2010. He also noted that Brisk Sanitation was having some truck problems, and that is why recyclables were not picked up until Saturday.

Chief Newkirk told the Council that the price for the new squad car was with trade-in of the car he is currently driving.

Dave Redeker asked the Council to consider hiring Kyle Jackson, Cody Jackson, and Jacob Speiser to referee soccer.

A motion was made by Alderman Jeremy Weh to approve hiring Kyle Jackson, Cody Jackson, and Jacob Speiser as soccer referees. Bill Gruen gave the Council details for the Citywide Auction. He thanked Steve Winterman for donating his time for this event. The Christmas in Carlyle group would like to have a food stand at the event. Mr. Winterman has offered to have it at his auction barn. Alderman Taylor noted that by having it at the auction barn they won't need a rain date, and they will have restrooms and a lunch stand. Steve told the Council that the only thing he will have to charge for is the check and credit card fees that he will have to pay for that service. Bill explained that the sellers will pay a 25% fee to have their items auctioned, and that fee will be donated to the city. Advertising for this event is estimated at \$1,500 to \$2,000. There was brief discussion. It was noted that the event is scheduled for October 10 and they will set a limit on the number of items each person can bring until they see how much they get.

Bill Gruen told the Council that he met with the Finance Committee to look at bids for stairwell repairs. The only bid received was from Rainey Construction in the amount of \$2,520.

Bill Gruen told the Council that 2 bids were received for waterproofing of the basement. The low bid was from Helitech at \$14,500. He noted that there is a ledge on the west wall. If they find that it is a footing, the seep tile will go on top of that, and there will be an additional cost of \$1,840. Alderman Kleber said he does not think it is a footing. There was discussion. Bill stated that LS Waterproofing suggested a few things that he thinks the city can do. He added that John's crew will have to do the lighting in the stairwell.

A motion was made by Alderman Mike Burton to approve transfers of \$10,000 to Street & Alley, \$60,000 to Police, and \$25,000 to Parks, for a total of \$95,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Ed Kleber, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

Alderman Burton presented a request to pay Beelman \$63 per yard for concrete for the 21<sup>st</sup> Street Project. The total cost is not to exceed \$6,500.

A motion was made by Alderman Mike Burton to approve up to \$6,500 for concrete from Beelman at a cost of \$63 per yard as requested. Alderman Perez reported that the Street & Alley Committee met on September 23. They hope to have Sand Ridge Road opened by September 30. He also reported that Super Valu wants to replace the sidewalk on the north side of their store at their expense. The residents at 490 Washington Street want to fix the sidewalk at that location, and the committee agreed to allow them to do it at their expense. Residents at 1190 Methodist Street would like to tear out the sidewalk there so they can get in their drive way. The committee approved. Alderman Perez also reported that there is a tree kicking up the sidewalk at the grade school, so they will be fixing it.

Alderman Burton reported that the EDC met regarding the Dairy Queen loan. It is an agenda item.

Mayor Fauke asked to add the audit review to the agenda after the Corps Handshake Grant Application. There were no objections.

Geoff Jones reported that they will start flushing hydrants on Monday.

John Hodapp reported that they will start on 24<sup>th</sup> Street tomorrow. He hopes to have Sand Ridge Road finished on Thursday. They will start on leaves the first week in October.

Dave Redeker reported that the last Movie in the Park will be shown on Saturday.

Jim Roeckeman reported that the library will have Story Hour on Wednesday, October 6, 2010. He also reported that they took in \$400 at the book sale last weekend.

Bill Gruen told the Council that the TIF Distributions that were approved last week were incorrect. The total amount is the same, but the distribution of the money has changed. He asked the Council to reconsider their previous approval and approve the new distribution as presented.

A motion was made by Alderman Mike Burton to resend the TIF Distributions approved at the last meeting and approve the new distribution as presented. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, and Don Perez; nay – none.

Bill Gruen reported that Helitech has started on the basement. He thanked Dave Redeker and his crew for help moving boxes.

Alderman Kleber reported that Bikes Around the Lake this year will hit Keyesport, Vandalia, Patoka, Sandoval, and Boulder and will end up at Bretz's Wildlife in Carlyle. He asked for help directing traffic. The bulk of the participants will leave at 11 a.m. Chief Newkirk said he can help out with the start. Alderman Kleber said the event attracted 436 motorcycles and they're hoping to get 600-700 this year.

Bill Gruen presented the handshake grant agreement for the River Walk Project. He noted that the grant application is stronger with backing from the city. The Corp is asking for \$15,000 in financial assistance plus \$15,000 in labor for installation of signs and benches. The City Progress Committee recommended approval.

A motion was made by Alderman Ed Kleber to approve the Handshake Agreement with the Corp for the River Walk Project with \$15,000 for materials and \$15,000 in labor as presented. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, and Brent Sheathelm; nay – none.

Kim Hammel thanked the city on behalf of the Corp.

Fred Becker presented the Audit Report. This report includes a letter from Bill Gruen with the city's upcoming expenses. Fred noted that state income tax is down with about \$50,000 less revenue and sales tax is up about \$24,000. It was also noted that IMRF costs are up about \$30,000 plus an increase in social security. Mr. Becker then reviewed the utilities summary. Water sales were up 10% from last year, but both years are down from previous years. Sewer was about the same and the Electric Department shows a loss of about \$82,000. The audit shows that the city is in pretty good shape, but he suggested they watch spending in the future. The Council will act on this audit at the next regular meeting.

Alderman Don Perez presented information on the labor contract. The starting base went up 25 cents, shift differential went up 5 cents and base for years 10 and 11 went up 65 cents. Everything else remains the same. This is a two year contract. Approval of this agreement will be on the next meeting agenda.

Bill Gruen presented information on the loan request for Dairy Queen. The owners have encountered some problems during renovation, and they are asking for a loan of \$184,630.65 from the revolving loan fund. Working capital is not to exceed \$25,000. The Economic Development Committee reviewed the application on Friday. The terms for the loan would be 10 years at 3% on the \$159,630.65 and 7 years at 3% on the \$25,000 working capital. The city still needs environmental clearance from the state before they can disburse the funds.

A motion was made by Alderman Jeff Taylor to approve the Dairy Queen loan as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none.

Bill Gruen presented information on Zoning Board actions. The first item was a re-write of street construction standards. There will be no oil and chip streets, and V-type curbs will require variance approval. They will update storm water inlets, and the city will no longer issue street names. Bill noted that the Zoning Board recommended approval.

Alderman Kleber asked about requirements for subdivisions currently being developed. Bill said he was not aware of any current developments. Alderman Kleber said he was referring to Dr. Bretz's property. Bill said that future development would have to meet the new code requirements. Dr. Bretz told the Council that he attended the Zoning Board meeting the other night, and the only item discussed was street thickness. He was told that other items were discussed at a prior meeting. The required thickness of the asphalt was discussed. No action was taken at this time.

Bill Gruen presented a request from St. Joseph's Hospital for a temporary parking lot variance and a temporary permit for their temporary building while they work on a permanent building. The temporary parking lot would be gravel. The Zoning Board recommended approval for a 12 month period. Alderman Taylor asked why they are asking for temporary approval when this property has been sitting there for 3 years. Mr. Klosterman responded.

Bill Gruen added that the parking lot would include 2 handicap spaces that would be cold patch. Mr. Klosterman noted that the lot would be oil and chip. Alderman Burton asked when they plan to break ground. Mr. Klosterman said they hope to start within a year, and it will take 5-6 months to construct. John Hudspeth told the Council that the previous CEO "left in a hurry" and they're trying to resume a normal course of business under the direction of Mr. Klosterman.

A motion was made by Alderman Brent Sheathelm to approve the temporary/special use permit as requested by St. Joseph's Hospital. The motion was seconded by Alderman Jack Satterfield and approved by the following roll call vote: Aye – Jeremy Weh, David Laws, Mike Burton, Ed Kleber, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – Jeff Taylor.

Bill Gruen presented a request from Dave Nordike for a zoning change at 1810 to 1840 Washington. He explained that there is a building there known as Westside Plaza that houses 4 separate units. It is zoned industrial which does not permit multi-family and residential use. Mr. Nordike owns 1840 Washington and wants to sell that property. The buyer wants to use it for residential purposes. The request is to change the entire building (1810, 1820, 1830, and 1840 Washington) to R5. The Zoning Board recommended approval. Alderman Burton asked Bill if he plans on changing it to B2. Bill said it's possible. There was discussion.

A motion was made by Alderman Ed Kleber to approve changing 1810 through 1840 Washington Street known as Westside Plaza to R5 as requested. A motion was made by Alderman Jack Satterfield to approve minutes from November 22, 2010, as presented. The motion was seconded by Alderman Mike Burton and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve claims as presented. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Mike Burton, Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

A motion was made by Alderman Mike Burton to approve the treasurer's report as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

Alderman Laws told the Council that the Water/Waste Water Committee met on December 6. Everything they discussed is on the agenda.

Alderman Weh said he received many compliments on the city park decorations.

Alderman Taylor reported that the City Progress Committee met and talked about downtown buildings. He encouraged people to submit pictures of the Christmas lights in the park.

Alderman Hoffman reported that the Library Board met last Monday. They will have a story hour on December 15 at 3:30 p.m. for kids ages 3-6.

Alderman Burton told the Council that the Finance Committee met and discussed risk management insurance for the upcoming year. Mr. Gregov with a competing company gave them another option. The committee recommended staying with IML for another year. It was noted that the city will save \$700 if they approve tonight and pay early. There was brief discussion.

A motion was made by Alderman Mike Burton to approve the IML Risk Management Insurance for another year as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, and Brad Hoffman; nay – none.

Alderman Burton noted that Mr. Gregov had a policy for the electric department that looked better than what we currently have. It will be discussed at a later date.

Alderman Laws presented a request from Tommy Hall to have a septic tank for his new home on 19<sup>th</sup> Street/Corey Road south of Ridge Street. Bill Gruen added that he would have 12

months to start construction. It was also noted that he would have to tap on to city sewer if it becomes available.

A motion was made by Alderman David Laws to approve the septic tank for the new home on 19<sup>th</sup> Street as presented. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, and Don Perez; nay – none.

Mayor Fauke presented the second reading of the Tax Levy Ordinance in the amount of \$247,659.

A motion was made by Alderman Jeremy Weh to approve the 2011 Property Tax Levy Ordinance as presented. The motion was seconded by Alderman Jeff Taylor and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, Don Perez, and Brent Sheathelm; nay – none.

Mayor Fauke presented information on the ordinance amendments to prohibit peddlers and solicitors permits to applicants with a criminal history. This constitutes the first reading.

Mayor Fauke presented information on the repayment of sewer overcharges to Carlyle North Lakeshore Acres. She stated that the city proposed an amount to them and the two parties agreed to an amount of \$27,069.41. The city will still owe them for 5 months. Fred Becker and Brian Buccheit are reviewing information to determine a reasonable amount.

A motion was made by Alderman Don Perez to approve payment of \$27,069.41 to Carlyle North Lakeshore Acres as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, Don Perez, Brent Sheathelm, and Jack Satterfield; nay – none.

A Multi-Hazard Mitigation Plan for Clinton County was presented by Bill Gruen. He stated that the Southwest Illinois Planning Commission works with several agencies to prepare a plan for Clinton County. They look at hazards most likely to be encountered, and they make recommendations for dealing with them. The Police Committee looked at parts of the plan, and it was reviewed by Ken Mehochko. Alderman Perez noted that if we adopt the plan, there is a chance we can get grant money for infrastructure.

A motion was made by Alderman Don Perez to adopt the Clinton County Multi-Hazard Mitigation Plan as presented. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, and Jeff Taylor; nay – none.

Bill Gruen presented information on the Cafeteria Plan Agreement Amendments. He noted that there is an agency that administers the plan, and they are asking for some amendments to the agreement. Ken Mehochko has reviewed the changes.

A motion was made by Alderman Mike Burton to approve the resolution to make amendments to the Cafeteria Plan Agreement as presented. The motion was seconded by Alderman Brad Hoffman and unanimously approved by the following roll call vote: Aye – David Laws, Mike Burton, Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, and Jeremy Weh; nay – none.

Mayor Fauke presented information on the subordination agreement with Nashville Savings Bank for the Dairy Queen loan. She noted that Dairy Queen is consolidating some of their loans, and the city wants to maintain second position. A motion was made by Alderman Brad Hoffman to approve the bank subordination agreement for the Dairy Queen loan as presented. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Mike Burton, Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, and David Laws; nay – none.

Mayor Fauke told the Council that the City Progress Committee discussed a new incentive program to encourage new construction that will be called the Rooftop Program. Individuals who construct a new, single-family home between March 1, 2011 and April 30, 2012 will be eligible for 1 year's worth of water, sewer, and electric not to exceed \$2,500. They will be required to pay electric tax, garbage, and recycling charges. A press release is available from Bill Gruen. There was brief discussion.

With no further business, a motion to adjourn was made by Alderman Don Perez and seconded by Alderman Brad Hoffman. The motion was unanimously approved by voice vote, and the meeting adjourned at 7:27 p.m.

#### CARLYLE CITY COUNCIL Regular Meeting Monday, December 27, 2010

The meeting of the Carlyle City Council was called to order at 7 p.m. by Mayor Jan Fauke on Monday, December 27, 2010, in the Carlyle Council Chambers.

The meeting opened with the pledge of allegiance.

A motion was made by Alderman Jack Satterfield to approve minutes from December 13, 2010, as presented. The motion was seconded by Alderman Don Perez and unanimously approved by voice vote.

A motion was made by Alderman Mike Burton to approve transfers of \$35,000 to Street & Alley, \$70,000 to Police, \$10,000 to Economic Development, \$25,000 to Parks, \$25,000 to Playground, and \$15,000 to Library for a total of \$180,000. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Brad Hoffman, Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, and Mike Burton; nay – none.

Alderman Mike Burton presented a request from the Electric Department for the purchase of a new truck. The committee recommended accepting a bid of \$20,395 from Wiegman Ford. This bid was a little higher than the lowest bid, but it included power locks and windows. Alderman Sheathelm noted that the other local dealers only gave bids for one option.

A motion was made by Alderman Mike Burton to accept the bid of \$20,395 from Wiegman Ford for a new truck as presented. The motion was seconded by Alderman Don Perez and unanimously approved by the following roll call vote: Aye – Don Perez, Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, and Brad Hoffman; nay – none.

Alderman Taylor reported that pictures of the Christmas lights and sponsorships are needed by the end of January.

Alderman Burton gave information on retiring the debt on Terminal 1 and the generator debt coming in 2014. He asked the Council to consider approval of an ordinance by March 2011 to recapture money and avoid a rate increase.

A motion was made by Alderman Mike Burton to approve the purchased power adjustment ordinance amendment and waive the second reading. The motion was seconded by Alderman Brent Sheathelm and unanimously approved by the following roll call vote: Aye – Brent Sheathelm, Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, and Don Perez; nay – none.

Dave Redeker reported that they will start taking down Christmas lights next Monday.

John Hodapp reported that the leaf program ended on December 22. It will start up again in late March or early April.

Chief Newkirk told the Council that they experienced a few burglaries from unlocked vehicles. He encouraged people to lock their cars and keep garage doors closed. Don Berdeaux asked where the incidents occurred. He was told that they were on the north end of town.

Jamie Kohrman addressed the Council regarding the Harvest Thyme Festival profits. A check in the amount of \$1,990.63 was presented to Dave Redeker to be used for park equipment.

Mayor Fauke told the Council that Josh Alberternst has completed one year with the city and asked them to consider hiring him as a full-time employee. Chief Newkirk stated that he is an excellent officer, and he highly recommended keeping him.

A motion was made by Alderman Don Perez to hire Josh Alberternst as a full-time employee as recommended. The motion was seconded by Alderman Jack Satterfield and unanimously approved by the following roll call vote: Aye – Jack Satterfield, Jeff Taylor, Jeremy Weh, David Laws, Mike Burton, Brad Hoffman, Don Perez, and Brent Sheathelm; nay – none.

Mayor Fauke presented the second reading of the peddler and solicitor permit ordinance amendments for applicants with a criminal history. Don Berdeaux said he thought the amendment was a little harsh. Mayor Fauke stated that people going door-to-door should be trustworthy. It was noted that Ken Mehochko told them that giving Kent the authority to choose could open the city up to liability suits. There was brief discussion.
