ORDINANCE NO. 1659

AN ORDINANCE TO AMEND CHAPTER 11-4-1 (J) OF THE REVISED
CODE OF THE CITY OF CARLYLE

WHEREAS, the City of Carlyle ("City"), Clinton County, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City Council of the City of Carlyle, Clinton County, Illinois believes that it is in the best interest of the residents of the City to amend Chapter 11-4-1 (J).

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL
OF THE CITY OF CARLYLE, CLINTON COUNTY, ILLINOIS:

That Chapter 11-4-1 (J) of the Revised Code of the City of Carlyle is hereby deleted and replaced with the following:

“(J) In addition to the cost referenced in Section (I), the City of Carlyle will charge a monthly Distribution System Utilization fee as follows:

<i>RESIDENTIAL</i>	<i>\$ 10.00</i>
<i>COMMERCIAL</i>	<i>\$ 15.00</i>
<i>LARGE COMMERCIAL</i>	<i>\$ 20.00</i>
<i>INDUSTRIAL</i>	<i>\$ 25.00</i>

The Distribution System Utilization ensures all customers pay a share of the costs of maintenance and improvements to the distribution system and is exclusive to customers who receive net metering services under this policy and represents the non-bypassable costs associated with maintaining the distribution system that backs up net metered generation.”

This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
