ORDINANCE NO. 1732

ORDINANCE REPEALING AND REPLACING CITY OF CARLYLE'S NET METERING POLICY AND INTERCONNECTION POLICY

WHEREAS, the City of Carlyle, Clinton County, Illinois ("City"), is a non-home rule municipality duly established, existing and operating in accordance with the provisions of the Illinois Municipal Code (Section 5/1-1-1 et seq. of Chapter 65 of the Illinois Compiled Statutes); and

WHEREAS, in 2018, City approved a Net Metering Policy and an Interconnection Policy for the Carlyle Municipal Electric Department; and

WHEREAS, distributed generation technology, including solar technology, and corresponding legislation has changed rapidly and dramatically over the past three (3) years; and

WHEREAS, the rapid and dramatic changes in distributed generation technology necessitates changes to City's Net Metering and Interconnection Policy; and

WHEREAS, the Carlyle Municipal Electric Department has proposed changes to the City's Net Metering and Interconnection Policies;

WHEREAS, the Carlyle Municipal Electric Department has submitted to City, and recommended the adoption of, a proposed Net Metering Policy (attached hereto as **Exhibit A**) and a proposed Interconnection Policy (attached hereto as **Exhibit B**); and

WHEREAS, City has determined the proposed Net Metering Policy (Exhibit A) and proposed interconnection Policy (Exhibit B) should be approved; and

WHEREAS, City has determined it is in the best interests of public health, safety, general welfare, and economic welfare to repeal the existing City Net Metering Policy and Interconnection Policy, and replace it with the proposed Net Metering Policy (Exhibit A) and proposed Interconnection Policy (Exhibit B).

NOW THEREFORE BE IT ORDAINED, by the City Council of the City of Carlyle, as follows:

Section 1. The foregoing recitals are incorporated herein as findings of the City Council of the City of Carlyle.
