

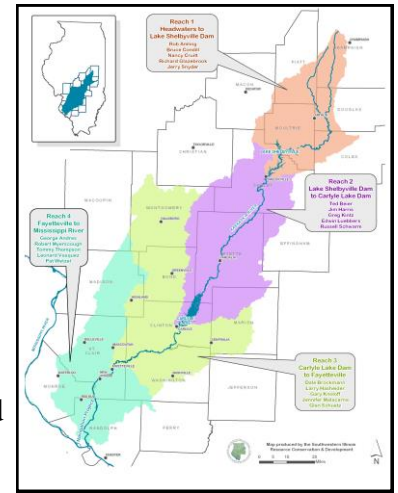

The Kaskaskia Watershed Association's 20<sup>th</sup> Annual Summit will be held on **March 2, 2020**, (9:00 am - 2:00 pm) at the Mariner's Village Resort Conference Center in Carlyle, IL. The theme for this year's Summit is **"Efforts and Needs for Continued Watershed Progress"**.



Over the past 20 years the Summit has brought together a diverse group of speakers that have helped with the understanding of our resources and how we plan to use them in the future. Nationally there is a demand to document conservation sustainability on the farm. The S.T.A.R. program is a tool that meets the demands of the public and provides for farmers to document their conservation and sustainability efforts. Hear from the leaders in this area.
