**ALL SEASON POOL PASS PURCHASES ARE FINAL. ABSOLUTELY NO REFUNDS FOR SEASON PASSES WILL BE OFFERED ONCE THEY ARE PURCHASED.**

Carlyle City Pool staff is authorized to close the pool and facility and clear it of all patrons, on a temporary basis, when it determines that inclement weather and/or water conditions threatens the health or safety of pool patrons including but not limited to:

- Lightning, thunder, or heavy rain
- Air temperatures below 60 degrees Fahrenheit and/or water temperatures below 68 degrees Fahrenheit
- Unsafe water chemistry levels and/or biological factors in the water

*Pass holders will not receive any type of compensation or reimbursement when the pool is forced to temporarily close.*

**Swimmer Disciplinary Policy:** *Pass holders will not receive any type of compensation or reimbursement of pass fees due to disciplinary action.*

- First Incident – Swimmer will receive a verbal warning by pool staff
- Second Incident – Swimmer will be asked to leave the pool facility for the remainder of the day
- Third Incident – Swimmer will be asked to leave the pool facility and will not be permitted to return for 7 days
- Fourth Incident - Swimmer will be asked to leave the pool facility and will not be permitted to return for 14 days
- Fifth Incident - Swimmer will be asked to leave the pool facility and will not be permitted to return for the remainder of the swim season
- Police will be notified for incidents including vandalizing City property and or criminal action on the premises and will result in the individual not being permitted to return to the pool facility for the remainder of the swim season.
