Customer will be subject to current rates, rules and regulations as approved by the City of Carlyle. <i>You must notify the City when you vacate to end service at the address you are vacating.</i> Otherwise you could be liable for any charges incurred after you have moved. Application for service shall be made in the legal name of the party obligated to pay for service.</p>
